## A “PRICEY” AND DIFFICULT PILL TO SWALLOW!

The hum of activity in the Raphael Community Free Clinic drug room is steady as staff and volunteers fill an average of 725 prescriptions per week for patient pickup. Pharmaceutical companies help in this effort through their Patient Assistance Programs (PAP), which allow qualified patients to receive their medications at no cost. Raphael Clinic is currently able to obtain approximately 50% of its medications directly from the original pharmaceutical manufacturers through these PAP programs.

Changes in the drug marketplace are having unforeseen consequences on the Clinic’s ability to obtain these medicines. A wave of patent expirations is accelerating toward what some are calling the “patent cliff.” When a patent reaches its expiration date, pharmaceutical companies remove these drugs from their Patient Assistant Program, making them inaccessible except for purchase by Raphael Clinic.



This widespread release of drugs for purchase and production by generic manufacturers is seen as a positive change for consumers, as they benefit from lower prices on generic but equivalent drug formulas. However, the manufacturers of generic drugs are using this “window of opportunity” to raise prices since the competition has narrowed and there are no price restrictions or controls from the U.S. Food and Drug Administration.

These unprecedented price increases have affected free clinics nationwide and some are closing because they can no longer afford to purchase very common medications. The chart below shows a sample of these price changes – with increases of 400% or more! Raphael Clinic is dedicated to providing the same quality of patient care, including medications, to its patients; however, budget restrictions limit quantities of medication able to be purchased at these increased prices.

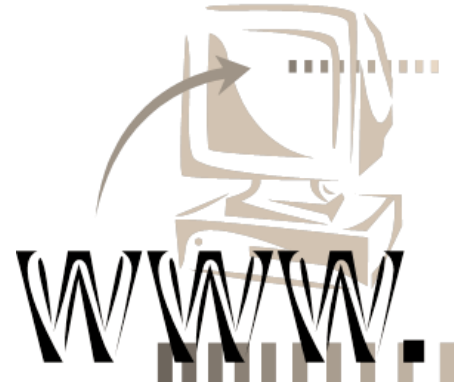

### *Collaborative effort brings online visibility*

Thanks to the persistence and technical expertise of a special volunteer, Internet users can now log on to [www.raphaelclinic.org](http://www.raphaelclinic.org) to see the clinic's operations "in action." A vendor representative on regular deliveries to the Raphael Clinic frequently questioned Sister Marge about creating a web page for the clinic, offering his services to help the clinic create an online presence.

Once a decision was made to proceed with the project, clinic staff worked together to search the clinic archives, and then compile, update and edit pertinent information to be included. Local photographer John Aceti contributed his talents to capture some "action shots." Drafts of designed pages were then turned over to Raptor Web Solutions to provide a professional look.



Raphael Clinic supporters will find information about different ways to contribute, including a link for online donations of any amount. Prospective clients can learn about the eligibility requirements to become a patient at the Raphael Clinic. Volunteer opportunities are listed, and potential volunteers can begin the process on the website by downloading the volunteer application and following up via phone or email with volunteer coordinator Joyce Horat.

The "News Desk" page allows supporters to stay updated on Clinic events with links to the organization's publications. And a new way to visit is offered via a link to a "virtual tour" on YouTube.

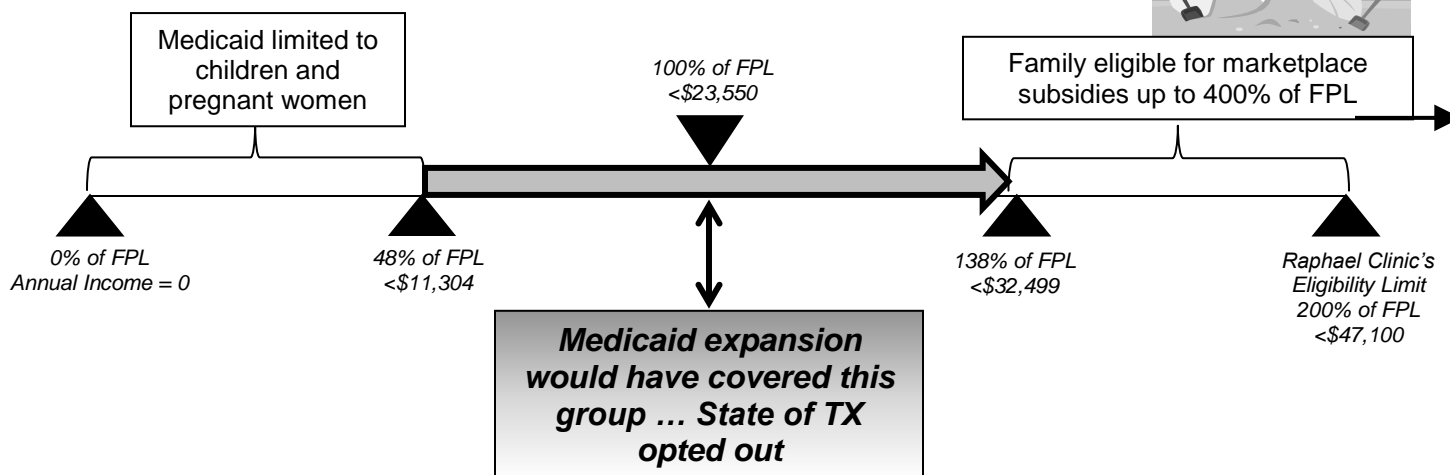
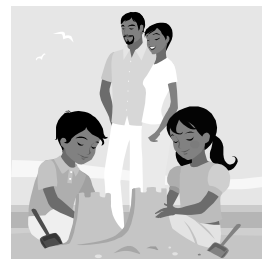

# AFFORDABLE CARE ACT (ACA) COVERAGE

Based on 2013 Federal Poverty Level (FPL)  
and a family of four In the State of Texas



Staff and volunteers at the Raphael Community Free Clinic have been faced with questions from patients and the public about whether it will be “going out of business” with the implementation of the Affordable Care Act. The above illustration shows those who are financially eligible for free medical services from the Raphael Clinic. With the State of Texas’ refusal to accept \$79 billion to expand its Medicaid program, it will instead be “business as usual” at the Raphael Clinic, with no dramatic decrease in the number of patients expected.

Texas leads all states with 25% of its residents living without health insurance, and the decision not to expand Medicaid will leave an estimated 2.5 million Texans with limited access to affordable health care services. Based on financial records clients provide to determine eligibility, approximately 10% of Raphael Clinic’s current patients may be eligible for a subsidy in the marketplace exchanges. Clinic health care providers are giving information to these individuals and encouraging them to investigate their options for health insurance coverage.

For our other hard-working neighbors who struggle to make ends meet and cannot afford health insurance, it is clear that Raphael Community Free Clinic will remain an important part of the community’s “safety net,” even after full implementation of the Affordable Care Act.

Regardless of political views about this law, Raphael Clinic will continue to carry out its mission:

*“To minister in a caring and Christian environment to the medically underserved of Kerrville and the surrounding area.”*
